THROUGH A SUBCONTRACT WITH TRILOGY, A COMMUNITY MENTAL HEALTH TRILOGY, NAMI CHICAGO HAS BEEN CONTRACTED BY THE ILLINOIS DHS TO PROVIDE OUTREACH AND PEER SUPPORT TO THE RESIDENTS AT ILLINOIS NURSING FACILITIES CATEGORIZED AS SPECIALIZED MENTAL HEALTH REHABILITATION FACILITIES SMHRFs AND SKILLED NURSING FACILITIES SNFs IN COOK COUNTY. OUTREACH WORKERS EXPLAIN TO THE RESIDENTS THEIR RIGHTS UNDER THE WILLIAMS AND COLBERT CONSENT DECREES AND PROVIDE SUPPORT AND HOPE DURING A TIME OF TRANSITION. IN THE WILLIAMS VS PRITZKER LAWSUIT AND THE COLBERT VS PRITZKER LAWSUIT, THE STATE OF ILLINOIS WAS FOUND IN VIOLATION OF TITLE II OF THE AMERICANS WITH DISABILITIES ACT.
