NAMI Chicago works with the Illinois Department of Human Services (DHS) to provide peer-based outreach and engagement for almost 600 individuals per year transitioning out of Specialized Mental Health Rehabilitation Facilities (SMHRFs) and Skilled Nursing Facilities (SNFs) into independent community living. Peer support specialists also provide in-home recovery support to individuals recently discharged from these facilities. Grounded in their lived experience, peer support specialists offer personalized guidance in adjusting to new environments, developing independent living skills, and managing potential stressors. They support individuals in their recovery journey and equip them with the essential skills to integrate into the

Helpline Team & 988 Crisis Contact Center:

NAMI Chicago operates a mental health information, referral, and crisis Helpline, providing immediate support, guidance, and referrals to individuals and families. Responding to more than 700 contacts per month via phone, text or chat, Helpline Specialists collaborate with contacts to explore their needs in a supportive, no-barrier space, providing emotional support and education to enhance their agency, self-advocacy, and understanding of mental health systems and resources. Follow-up contacts offer the opportunity to support resource usage and strengthen help seeking behaviors.

Through the 988 Crisis Center, NAMI Chicago provides urgent mental

Mental Health Court Advocates, Case Managers & Clinical Support Teams:

NAMI Chicago provides comprehensive care coordination and case management services designed to break cycles of crisis and create lasting pathways to wellness. The department serves individuals and family members during periods of high need, particularly those involved with emergency response or criminal court systems due to their mental health needs. Case managers serve as educators, advocates, and system navigators, helping participants and their families understand complex service networks, exercise self-determination, and access critical supports that promote stability and recovery. The teams engaging in intensive case management serve over two hundred and fifty participants annually, across programs.
